Additional Prescribed Coursework

Writing Requirement	Two courses beyond RHE 306 or its equivalent identified with a writing flag. One of these courses must be upper-division. Three hours of writing flag must come from a course that does not otherwise satisfy a core requirement. Writing flags may be used simultaneously to fulfill other requirements, unless otherwise specified.
Foreign Language/Culture Requirement (choose one option)	 Second-semester-level proficiency in a foreign language; First-semester-level proficiency in a foreign language and a three-semester-hour course in the culture of the same language area; or

Social Sciences Requirement ¹⁶	Three semester hours chosen from an approved list of social science courses are required, in addition to the course counted toward the social science area of the core curriculum.
Cultural Expression, Human Experience	Three semester hours of designated coursework from the Cultural Expression, Human Experience and
and Thought (CEHET) Requirement ¹⁴	Thought area are required. The course must be in a field of study in the College of Liberal Arts. A course counted toward any core curriculum requirement or any portion of the EVS Prescribed Work may not also be counted toward this requirement.
